### **CHAPTER ONE**

### INTRODUCTION

## 1.1 Background of the Study

Literary works are places to express ideas and thoughts with experiences. Afrianto (2018) implies Literature manifests the sense of the content and message that can be shared in texts. The literature presents the inner experience experienced by the author to the connoisseurs of literary works (society). Jannah (2017) argues that literature is a form of human expression that involves thoughts and feelings. Literature also does not forget to use every means to entertain people so that they understand its meaning because it is a work of emotions and imagination (Hermawati & Fithratullah, 2022). Literature is not only a reflection of society but also an expression of an idea about the world or an idea about sociological reality that is timeless. According to Laurenson & Swingewood (1972), literature is penetrating the surface of social life, showing how men and women experience society as feeling. Therefore, a literary work generally contains the problems that surround human life.

Literature exists because of the basic human background and the urge to express their existence. Sangidu (2004) states that human and humanitarian problems and their concern for the world of reliability have lasted throughout the ages. Furthermore, Semi (1989) mentions literature is an imitation or integration of reality with the author's imagination or the result of the author's imagination departing from reality. It can be described that sociological mimesis seeks to understand literary works such as novels based on characterizations, social life, activities, social status, character behavior, and events that occur in them. Mentari & Samanik (2022) state from a literary work we can gain broad knowledge about what happened at that time such as the social conditions faced by the author in a novel or literary work. Literary works, including novels, often allude to people's relationship with all their problems. This relationship can be in the form of people with people, people with their creators, to the relationship between people and nature or the environment in which they live. Valuable elements in the novel regarding the relationship between people and their environment include sociocultural factors, the use of natural resources, the value of care and conservation environment, etc.

Social life is the relationship of human interaction with one another in an environment or society in general. Hossain and Ali (2014) state that human life is mostly group life. This study uses the *Serena* novel written by Ron Rash, a novelist, poet, and story writer from America. This novel was published in 2008 by HarperCollins Publisher. The set in 1929s in North Carolina where in that year the great depression is in full swing and Americans everywhere find jobless and poverty. Serena novel tells the story of a woman named Serena. Serena is the wife of a North Carolina lumber businessman named George Pemberton. They met in Boston, married, and moved to North Carolina. People in North Carolina Mountain are loggers. Their social activities include hunting and logging. Serena is very different from what the locals (poor but resilient mountain folk) are used to. She hunts and rides like a man, knows how to cut trees as much as a logger, and is a highly skilled businesswoman. Serena continues to impress the men at the camp with her knowledge of the logging business, her acumen with a rifle, and even her ability to train an eagle to kill a rattlesnake. Serena had everything she wanted, except she couldn't have children. When she was pregnant, there was an incident that made her lose her child. Until Rachel Harmon got what Serena wanted, and it was Pemberton's child. Making Serena worried about stealing her husband's attention and affection. Out of jealousy, she did everything possible to prevent her husband from paying attention to her child. Starting from preventing her husband from giving money to the child to trying to kill the child by ordering one of her husband's employees.

Ron Rash was born in Chester, South Carolina. He is an American writer of novels, poetry, and short stories. He has been awarded a number of awards for his work. Rash draws on a deep sense of place in the Appalachian region that emerges

in his work. He evokes the beauty and brutality of the land and the relentless tension between past and present. Ron Rash of Western Carolina University is known as a leading practitioner of what critics call "Appalachian noir". His stories and novels are usually set in North Carolina's Appalachian Mountains, but there is little that is strange and simple about them. According to some readings, 1929 was the time when the North Carolina stock market in the United States crashed in an event known as Black Tuesday. This set off a chain of events that led to the Great Depression, a 10-year economic crisis that affected every industrialized nation in the world.

Based on the background above, the study chooses *Serena* novel as believed that it reflects social activities and marriage life. The story seems to have a connection with Ron Rash's life and the social condition of North Carolina in 1929. Thus, the researcher uses a sociological approach to identify social activities and marriage life in the novel.
