There are several types of literary works, one of which is film. Klarer (2004) says that film has deep artistic potential and is able to

Sikov (1998) argues that film is the art of space and time, that is, film is a combination of how everything looks (space) and how everything develops as the story progresses (time). Cavell (1979) adds that film is the art of events, movement and expression. Cavell (1979) also claims that through movement and expression in film, we can think about the meaning of human existence and how morality is applied to a person. He emphasized that the dialogue and interaction between character that occur in the film is a means to seek understanding of oneself and social relationships. Film and popular literature are closely related because they are considered to be used to convey messages about cultural and social issues in society in a community work. (Kasih & Fitratullah, 2018).
